Project's Site Plan Revised, Mutuals to Receive Updated Version

Revisions to the Administration Building and Clubhouse I Site Plan will be presented at monthly mutual meetings in the coming months.

In response to recommendations made by the Montgomery County Planning Board at a Nov. 30 application hearing for the project, the project's designers have made adjustments to the plan regarding building entrances and traffic flow.

Leisure World management will explain the revisions to the plan and answer residents' questions about the project at mutual meetings scheduled for late January and early February.

Representatives from Leisure World; Stantec, the engineering firm; and Streetsense, the architectural firm, met Dec. 8 with County Planning Board staff to discuss and develop options related to suggestions by the Planning Board on Nov. 30. The group expects to meet as often as needed until plans are finalized satisfactorily.

Planning Board staff, which

comprises professional site planners, engineers, architects and transportation specialists, had recommended the Planning Board approve the site plan at the Nov. 30 hearing.

Project Overview

The site plan is the most recent project to be addressed in Leisure World's Facilities Enhancement Plan (FEP), a series of construction and renovation projects for the community's Trust facilities that originated in 2012.

Completed FEP projects, designed and undertaken since 2014, include construction of the new Clubhouse II fitness center, renovations to the restaurants in Clubhouse I, renovations to the Clubhouse I ballroom and Maryland Room, dredging and landscaping improvements of the golf course irrigation pond, and renovations to the Physical Properties Department customer service area.

The site plan application calls for construction of a two-level building adjacent to Clubhouse I that will provide residential services, additional parking and

Ways to Protect Your Hearth and Home this Holiday Season

With the holidays quickly approaching, the community is expected to experience an uptick in outside visitors and delivery personnel, said Richard Schultz, Director of Security and Transportation. Although theft and other crimes can occur at any time within a gated, age-restricted community, residents may consider taking added precautions this time of year to ensure their personal security.

Make a List, Check it Twice

The holidays are a good time to update or create a home inventory. The Montgomery County Department of Police recommends taking photos or videos of valuables in your home, such as jewelry, electronics and tools – typical items stolen. List descriptions of each item, including make, model and serial numbers. If your home is burglarized, having a detailed inventory can help identify stolen items and make insurance claims easier to file.

Lock it Up

It may be tempting to leave heavy packages and bags in the car after a long day of shopping, but police and security officials warn against leaving anything

valuable in a vehicle.

“I advocate locking your car, just like you would wherever you parked it,” Schultz said. “There are a lot of visitors and guests that come in here.”

On its website, the Montgomery County Department of Police describe burglar safes as an effective tool for safeguarding money and valuables. It’s important to note however that although burglarproof, these types of safes may not protect items from charring in a fire.

Just Visiting

Residents expecting up to five visitors in a day, whether family members, friends or delivery personnel, should call the main gate at (301-598-1044) and inform the gate guard. The visitor list is distributed to all three gates, and visitors will be stopped and asked whom they are here to visit. If a resident is expecting more than five visitors, they must fill out a written form, which is available at the security office in the Administration building, or visit (residents.lwmc.com) and click on the Incoming Visitor Form on the Security and Transportation page.

“If you’re having a holiday party with maybe 20 people, we don’t require that you put down 20 names,” Schultz said; adding that residents filling out the

visitor form can simply request that gate guards admit anyone who identifies themselves as a guest of said resident.

Residents with the same frequent visitors can request up to eight guest passes, valid for one year; and such visitors must present their guest pass before entering at the gate.

“I always tell people to be careful who they give those cards to, because they then have access to the community at any time,” said Elisabeth Hamilton, administrative coordinator of the Security and Transportation Department.

Residents may also obtain up to three contractual passes for caregivers and other service providers, and these passes are not included in the eight allotted guest passes.

With the exception of delivery and some other personnel, if a visitor does not present a guest pass, or is not on security’s list of expected visitors for that day, then the gate guard will call the resident to verify they are expecting the visitor. If the gate guard cannot get in touch with the resident, then the guest is not allowed to enter the community.

Beware of Strangers

Criminals sometimes take advantage of an individual’s trusting nature by posing as

delivery carriers or charity collectors. If a stranger knocks on your door, the Montgomery County Department of Police recommends asking the person for identification, so that you can verify that they are who they claim to be. Always err on the side of caution; there’s no shame in turning away someone you do not trust.

General Information

The community is patrolled by special police officers (SPOs) 24 hours a day, seven days a week. SPOs hold a commission granted by the governor, which generally authorizes the officer to arrest individuals who trespass or commit offenses on the property described in the commission, according to (mdsp.Maryland.gov).

Residents can report any concerns or suspicious activity to security by calling the main gate at (301-598-1044). Residents may also contact the Montgomery County Department of Police at (301-279-8000) to report non-emergencies.

“If you see something, say something,” Hamilton said.

pedestrian accessibility to Clubhouse I, further improvements to the Clubhouse I restaurants, a new drop-off and pick-up loop area between the two buildings, and extensive landscaping and tree plantings throughout the site.

In its presentation recommending Planning Board approval of the site plan application, Planning Board staff cited the project's compliance with improved pedestrian and vehicular access and circulation to Clubhouse I, Environmental Site Design stormwater management controls, and the county's International Green Construction Code.

Deferral

The Planning Board voted to defer its decision on the application at the Nov. 30 hearing, with some board members citing concerns about a set of steps included as access to the new building. Plans also called for two ground-level entrances and a ramp.

Eighteen residents testified at the Nov. 30 hearing in opposition to the project, citing environmental, aesthetic and cost concerns as well as the inclusion of steps leading into the proposed new building. Several asserted

that residents have not been sufficiently informed about the project by the LWCC board of directors and management.

The Planning Board expects to reconsider a revised site plan application at a hearing in the spring of 2018.

Take Two

In anticipation of the Board's future consideration of the application and associated hearing, written comments from Leisure World residents should be submitted to Planning Board Chairman Casey Anderson at (mcp-chair@mncppc.org) with a copy sent to Area 2 Lead Reviewer Lori Shirley at (Lori.Shirley@montgomeryplanning.org).

Once the continuance of the public hearing is scheduled, a Planning Board staff report will be posted 10 days before the Planning Board meeting at (montgomeryplanningboard.org). Staff comments will be shared with the applicant and added to the record for the Planning Board's consideration of the application.

Neurologist Arrives at MedStar in January

Dr. Sirdar Bilaal, a board certified neurologist specializing in vascular neurology, expands his clinic to include MedStar Health medical center beginning Wednesday, Jan. 17. He will be available to residents at the medical center on Wednesday afternoons from 1-5 p.m.

Neurologists examine, diagnose and treat conditions and diseases involving the central and peripheral nervous system, including dementia, Parkinson's disease, epilepsy, stroke, neuropathy, neuromuscular disorders and multiple sclerosis.

"There's a lot of need for neurology at Leisure World," Bilaal said.

Bilaal will continue to see


patients at MedStar Georgetown University Hospital in Washington, D.C., and in the outpatient clinic at MedStar Montgomery medical center, where several of his patients are also Leisure World residents.

"They're all well-educated, plugged-in and engaged, and take their health seriously, he said, adding, "It's good to interact with and treat patients who make their health a priority."

Bilaal completed a fellowship program at Rush University Medical Center in 2015, and his medical residency at the University of Illinois at Chicago a year prior.

How to Save Energy During Winter

Everyone can make small lifestyle changes, with little to no extra cost, that can impact levels of energy consumption during the winter months.

Checking on Temperature

Setting a home's thermostat lower during winter helps the system use less electricity. To accommodate thermostat

changes, consider dressing in sweaters and heavier clothing.

Lower the temperature overnight. This will not only save energy, but may also make sleeping more comfortable. Programmable thermostats are helpful. Using a humidifier when the humidity falls below 50 percent may increase a home's comfort.

The water heater is one of the highest energy users in the home.

Check its temperature setting; if the water is very hot, consider a lower setting. PEPCO recommends setting it at 120°F, which also prevents burns and scalds.

Replacing Light Bulbs

Compact fluorescent lamps last up to 10 times longer than incandescent bulbs. Light-emitting diodes (LEDs) use 75-80 percent less energy and have a lifespan up to 25 times longer than traditional incandescent bulbs, according to (energy.gov).

LEDs combine brightness with lower energy consumption. The soft white LEDs are 2700K color temperature and the daylight LEDs are 5000K color temperature. You might prefer the brighter daylight versions for your house except for the bathroom, where the soft white might make you look less pale.

Lights

Turn off lights when leaving a room for more than 15 minutes. Instead of leaving outdoor lights on all night, install lights with motion detectors that turn the lights on only when needed.

Doors and Windows

If you have a storm door outside the doors to your home, don't keep the inside doors open when the heat or air conditioner is operating. For homes with attached garages, keep the garage door closed to act as a buffer from the outside temperature. When the temperature outside is comfortable, try turning off the heat and opening the windows.

Low Cost Things to Do:

- Wash clothes in cold or warm water instead of hot.
- Add weather stripping around doors and caulking around window frames. Weather stripping can break down or become damaged over the years, so periodically check the condition of weather stripping around doors and windows and replace as needed.
- Inspect and seal leaks in ductwork, especially where the ducts join the vents, using caulk or special tape. Place foam sheets behind outlets and switches on exterior walls; these sheets are available at

any hardware store.

- Have heating and cooling systems inspected and serviced yearly to ensure they are operating efficiently.
- Ensure the fireplace damper fits properly, and/or install a glass fireplace screen. If no longer using the fireplace, use rigid-foam insulation cut to cover the damper area, caulked into place, to permanently eliminate drafts.
- Depending on the type of filter a furnace uses, check it every two-three months, and clean or replace as necessary.
- Close the air vent in a room(s) that's rarely used.
- Unplug electronics and chargers that are not in use. Many of these devices draw low current to be on standby. Alternatively, plug all electronics into a power strip that has a surge protector and an off switch. When going to bed or when away for days, turn off the power strip.
- When leaving for several hours or days, lower the temperature to no lower than 50 degrees.

Investments that Reduce Electricity Usage:

- If the air handler for a heat pump or air conditioner is in the garage, have the visible ducts insulated with fiberglass. If other portions of the air handler appear to be leaky, seal openings and insulate as appropriate.
- Buy and install only appliances with an Energy Star label. Check with PEPCO for possible rebates.

The following three items require an application for building modification (ABM) and mutual board of directors' approval:

- Replace the baseboard heat and air conditioning systems with an energy-efficient, heat pump that provides both heating and cooling in one system.
- Properly insulate an attic. Improperly installed insulation can trap moisture and reduce the life expectancy of the roof.
- Install energy-efficient windows and doors with a low U-Factor for more comfort and efficiency.



Leisure World Snow Plan 2017-2018

Blueprint for a Safe and Healthy Winter

When Montgomery County authorities announce a snow emergency, snow emergency restrictions become effective in Leisure World as well.

Leisure World is private property encompassing 55 miles of roads and walkways. The county and state do not provide assistance during a snow emergency.

When Snow Begins to Fall

The first priority is to provide continued access for rescue vehicles and automobiles required by residents who might need emergency medical care. The MedStar Health medical center will be given top priority at all times.

Snowplows will clear primary access roadways, parking lots and driveways in the following order:

1. Through Streets:

Rossmoor Boulevard, South and North Leisure World Boulevards, Interlachen Drive, Norbeck Boulevard, Gleneagles Drive, Chiswick Court, Connecticut Avenue, Kelmscot Drive, Hyde Park Drive, Twin Branches Drive, Fitzhugh Lane, Tarkington Lane, Prince Frederick Way, Pine Orchard Drive and Pennfield Circle.

2. Primary Access

Roads: Fiske Drive and Terrace, Edelmar Drive and Terrace, Ludham Drive, Forest Edge and Glade Drives, Vantage Hill Road, Bramblewood Drive, Bassett Lane and Glen Eagles Drive.

3. Remaining named "Courts," "Squares," "Terraces" and "Ways" that serve a dozen or more units.

4. Driveways providing access to less than a dozen dwelling units.

When the Snow Stops Falling

Shoveling crews will start clearing entrances and sidewalks at the Club-

houses and Administration Building, if the facilities are open, followed by the primary access paths for apartment-style buildings and individual units (primary access means from main entrance to parking lot). In apartment-style buildings, if you do not use the front door as primary access because of a disability, call the **Grounds Maintenance Department (301-598-1314)** to arrange special clearing.

Machine clearing of perimeter walks and other long stretches of walks will be done concurrently. Because machine clearing is much faster, these long walks may be completed before hand-shoveling crews have reached other primary access walks.

The snow plan calls for access to a primary roadway, including sidewalks:

- within 24 hours after the precipitation has ended for snowfalls of 12" or less,

- within 36 hours after the precipitation has ended for snowfalls of 12-24"

- within 48 hours after the precipitation has ended for snowfalls of more than 24"

Parking Restrictions

During the snow emergency, do not park on any street designated as a Snow Emergency Route. These include Rossmoor Boulevard, Leisure World Boulevard, Gleneagles Drive, Chiswick Court, Interlachen Drive, Norbeck Boulevard and Connecticut Avenue.

Do not park in Reserved or Visitors parking spaces in your parking lot. Your Mutual may have designated these spaces as areas for snow handling. Residents affected will be contacted by their Mutual to move their vehicles to assigned temporary parking spaces prior to snow removal.

The director of Security and Transportation or a special police officer (SPO)

can assist in identifying a resident whose automobile may be obstructing snow removal operations.

Clearing Snowbound Vehicles

McFall & Berry Inc.'s contracted services do not include shoveling out parked vehicles.

If necessary, call a relative, friend or neighbor to request help. Another option is to use the services of individuals who will do the work for a fee.

Security requires anyone wanting to shovel out residents' cars for a fee to register with the Grounds Maintenance Department at (301-598-1314). The department maintains a list of individuals who have been pre-approved. If you know of anyone interested in providing this service, have that person call the Grounds Maintenance Department as soon as possible. The department will provide identification cards. Security requests that you report any individuals who do not have proper ID.

The Grounds Maintenance Department does not set shoveling fees, nor is it responsible for any damages that may be incurred. See page 6 for a list of snow shovelers.

When you Need Medical Attention

- **Call 911 for all medical emergencies.**

- Notify the **Grounds Maintenance Department (301-598-1314)** at least three hours in advance of a medical appointment you are unable to reschedule. Make sure your medical facility will be open; do not make any assumptions that it will be.

- Call the Grounds Maintenance Department to have your name placed on a snow clearance priority list if you have an ongoing critical medical requirement such as dialysis, oxygen, chemotherapy, radiation, etc.

Updates

- Call the Daily Events Line at (301-598-1313) for up-to-date snow-related information, including trash pick-up, bus scheduling, cancellation of Clubhouse I and II events, activities and facility closings.

- Check the Leisure World closed circuit TV channel 972 for snow-removal updates.

- Check the residents website (residents.lwmc.com) homepage for snow removal updates.

Communication

- Call the **Main Gate (301-598-1044)** to report stuck vehicles or accidents.

- Call the **Grounds Maintenance Department (301-598-1314)** with your snow clearance inquiries. Due to the high volume of calls and the department's need to be out overseeing snow-removal operations, calls will be monitored and prioritized on a regular basis around the clock. Calls will be returned as quickly as possible according to urgency.

- Do not call the McFall & Berry office for routine information, complaints or scheduling issues.

Additional Advice

- In preparation for a potential snow emergency, now is a good time to stock up on essentials such as food and medicines, and other items such as batteries and reading materials. Be prepared to keep at least one week's supply of essentials on hand during the winter months.

- During a snow emergency, if you are in doubt about venturing from your residence, it is best not to go out. Also, wait until conditions are safe before putting out trash or retrieving newspapers.

Contempt for Residents Must Stop

I attended and testified at the meeting of the Montgomery County Planning Board on Nov. 30, where a lawyer hired by the LWCC board and a LWCC board member attempted to convince the Planning Board to approve the project to tear down the Leisure World's existing Administration Building and build a new one, with lots of attendant tearing up of trees and parking lots.

I was amazed at the contempt shown by the lawyer hired by the LWCC board for the residents of Leisure World. He told the Planning Board that what Leisure World residents want is irrelevant to the proceeding and not within the jurisdiction of the Planning Board. Yet we, the residents of Leisure World, are being forced to pay this lawyer, probably many hundreds of dollars per hour.

In my opinion, we are paying him to insult us and show contempt for us.

Fortunately, the Planning Board responded to the dozens of residents who testified and asked that the new Administration Building project be rejected or at least delayed until all relevant facts could be investigated. One member of the Planning Board said part of the plan – steps in the new Administration Building – was so awful that she would never vote to approve it. Another member of the Planning Board said he was amazed that the LWCC board of directors had apparently made no effort to work with residents, or even talk with them. The chairman of the Planning Board said he was troubled by my testimony that the LWCC board had not followed proper procedures in its consideration of the plan to tear down the present Administration Building and build a new one.

The lawyer for Leisure World urged the Planning Board to take a vote at the

Nov. 30 meeting, and the Planning Board chairman said if they took a vote then it would probably be to reject what the lawyer and the LWCC board wanted. The lawyer quickly then said they would make changes in the plan and asked the Planning Board to vote for it based on that statement. The Planning Board refused to do so.

So what happens now? The Planning Board deferred action on the request for approval of what the LWCC board wants. The members of the Planning Board urged the LWCC board to meet and talk with residents, come up with compromises, and show that the LWCC board cares about what residents think. Will the LWCC board be willing to compromise? Will the LWCC board members show respect for residents? We will see.

Appreciation

I just want to express my appreciation to the "Leisure World News of Maryland" for its local reporting of subjects of interest and notices of events in Leisure World. I am especially grateful for two recent examples.

The first was published in the Nov. 3 edition and informed the residents about a seminar sponsored by one of the clubs in our community. The topic was "Open Season for Federal Health Plans" and featured a number of health plan representatives. While it was aimed primarily at federal health plan subscribers, there was information of interest to "civilian" retirees, such as AARP legislative information on taxes and financial planning. If the

club had not submitted a notice for publication, I would not have known about the meeting and would not have had the opportunity to attend. Based upon information learned from this seminar, I was able to make an informed decision to change my health plan and improve both my health coverage and finances. Notices of club events published in the Leisure World News really do serve a useful purpose for our residents.

The second article was published in the Nov. 17 edition and provided "Frequently Asked Questions" regarding the proposed new Administration Building and Clubhouse I Site Improvements project. It was extremely helpful and the reporting appeared to be quite objective. Perhaps, had this information been published sooner and repeated on a regular basis (quarterly?) for new residents, some of the controversy surrounding the project could have been avoided. For example, I frequently heard that the \$7.2 million estimate was a five-year-old estimate but the article advises that the estimate was made in September 2016. That is quite a discrepancy in time and it allays one of my concerns. And, there was other information contained in the article that I did not know. While the article may not change my opinion regarding whether the new building is warranted, at the very least, I better understand the situation and appreciate that I was not subjected to embellishment or hyperbole.

In closing, I am amazed how much I rely on our community newspaper. Please keep up the good work!

Jan. 20: A Tribute to Benny Goodman's Carnegie Hall Concert

Eighty years ago, on Jan. 16, 1938, Benny Goodman brought American jazz to Carnegie Hall.

Goodman, already known as the "King of Swing" and a star of radio, stage and film, was at the height of his career when his publicist suggested that he perform at Carnegie. Initially dismissing the idea, he changed his mind, and the concert that resulted may be the most important jazz concert in history.

The concert included not only performances from Goodman's band, but also by such well-known jazz artists as Harry James (trumpet), Lionel Hampton (vibraphone) and Gene Krupa (drums). It also featured a new piece, "Twenty Years of Jazz," and a jam session with performances by members of the Duke Ellington and Count

Basie orchestras. Amazingly for the time, the concert sold out weeks in advance.

On Saturday, Jan. 20, at 4 p.m. in the Clubhouse II auditorium, clarinetist William "Bill" Wright presents a program commemorating this event. He will play many of the same songs Goodman did that night in 1938.

Wright is a musician who is equally comfortable playing classical music as jazz. During his 40 years with the National Symphony, he toured throughout the U.S., Europe and South America. 

FISH started in Leisure World in 1969 and has been serving the community ever since. Its mission is to lend assistive equipment to residents of Leisure World and employees.

FISH receives donated, usable medical equipment, such as wheelchairs, walkers, commodes and tub stools. The organization also receives canes, crutches, elevated toilet seats and easy reachers, which it happily donates to residents.

Other available donated items include incontinence items, blood pressure monitors, wheelchair pillows and baskets and trays for use on walkers. Most of these items are stored in the FISH office's closet.

The closet also houses lost and found items turned into E&R. Residents who have lost an item should keep in mind that some Mutualls have their own Lost and Found collections. FISH recommends that residents place an address label on items they borrow.




Members are also invited to make suggestions for improving the Club. Those who are interested in running for local political office but cannot attend the December meeting are asked to contact the Club president about their interest.

Health Roundtable Closes Autumn Program

The chapter closed the autumn portion of its agenda with the long-planned and long-anticipated Health Roundtable. On Nov. 20, retired seniors, both federal and non-federal, gathered in the Clubhouse I Crystal Ballroom for the largest event the chapter has ever held.

The roundtable gave seniors information needed to make crucial decisions in a rapidly changing health care system, and also provided information about potential threats to Medicare, Medicaid and Social Security.

Two roundtable speakers, former legislative vice president of NARFE Dan Adcock from the Committee to Preserve Social Security and Medicare, and Jessie Lee Washington from New York Life, have addressed the chapter previously.



When Adcock addressed the chapter last year, members learned that seniors face potential threats to their Social Security and Medicare. More than a few members thought they had weathered the storm, as a series of bills were defeated.

With the new budget passed by the House of Representatives (HR-1), however, potential threats to seniors' benefits and healthcare are still a concern.

The budget eliminates many benefits and tax deductions that impact seniors. As the budget stands, the medical deduction could be eliminated.

About three fourths of the 8.8 million taxpayers who rely on this deduction are seniors. The fiscal crisis created by the healthcare debate may result in a trillion dollar cut in Medicare funding.

The plan to use the "chained" consumer price index may slow growth of tax deductions. The chapter hopes that those who attended the roundtable will spread the word.

Managing Safari Preferences: Part 2

Websites is a new preference in High Sierra and one that will significantly enhance users' web surfing experience. In general, the Websites preferences allow users to customize how individual sites appear on their computers and how they behave.

Open Safari > Preferences > Websites, and a sidebar appears on the left of the screen with various categories; the first one is Reader. Users can set Reader to be activated for individual sites automatically; clicking on an article in that site will render the article in Reader.

Users can also globally set Reader to be activated for all sites using the popup menu at the bottom right. Users can open any site in which they always want to use Reader to read articles, then just open the Websites preference pane and select "On."

The Content Blockers preference lets users choose to stop ads and other unwanted content from appearing on specified sites, or to block them globally. Does it annoy you to visit a website and be immediately blasted with a YouTube video? The Auto-Play preference allows users to suppress this disturbance for good.

One particularly valuable preference is Page Zoom. Page Zoom lets users to increase the font and image size by a percentage over the published size. Users can set one site to 125 percent and another to 150 percent or more. The Websites preference also shows a list of all the sites that a user has configured, plus the currently open websites, together with their associated zoom level percentage.

Some sites will ask to enable a user's Camera or Microphone or to allow the site to use a user's Location. The next three Websites preferences, which have popup menus to allow control, are Ask, Deny or Allow for each specific site. The Notifications preference lets users Allow or Deny individual sites to show alerts in the Notification Center.

The bottom half of the Websites preference pane concerns the management of Plug-ins. Websites use plug-ins for pictures, music, video, animation, interactive features, and other enhancements. Some plug-ins track a user's browsing history.

The list of available Safari Plug-ins is in the Sidebar and can be turned on (checked) or off (not checked) there, or controlled in the associated window. To get detailed information on the use and control of Plug-ins, click the small encir-

led "?" in the lower right of the window for the associated help window.

Go back to the top of the window and select the Privacy pane, where there are two important items. Some websites use third-party content providers. A third-party content provider can track users across websites to advertise products and services. With "Prevent cross-site tracking" turned on, tracking data is periodically deleted unless a user visits the third-party content provider.



Some websites keep track of a user's browsing activities when the user visits, which enables them to tailor what they present to each user. Users can ask sites and their third-party content providers (including advertisers) not to track them.

With the "Ask websites not to track me" option turned on, each time a user gets content from a website, he or she can add a request to not be tracked;

but it's up to the website to honor this request.

Today's Tip – Create a Shadow-Free Screenshot

Pressing Command-Shift-4 allows users to select a specific area of the screen to capture. If a user then presses the space bar, he or she can click a window to take a cropped screenshot of just that window.

The Mac automatically adds the shadow around the edges of the screenshot, but users who prefer a flat, shadow-free image of the window should hold down the Option key as they click to snap an image of the selected window.

Chess Club

Forget the Sleigh; Make it a Drone

*'Twas the night before
Christmas and it was
freezing outside,
But Santa and his reindeer
were enjoying the ride.
They cruised over fields and
mountains with speed,
Avoiding politicians' debates
we don't really need.
Oblivious to the economy and
political rifts,
Santa kept delivering the
season's gifts.
No lumps of coal, but plenty
of chess sets.
This was no time to think of
taxes and debts.
So joy to you all. Keep the
holiday spirit alive.
Don't worry about money.
We'll all survive.*

Commercially, to handle the Christmas mail, the U.S. Postal Service is making home deliveries seven or eight days a week. It expects to deliver 850 million packages during the holiday period this year, according to an October 2017 press release from the agency.

The major package delivery services also will deliver millions of packages: UPS estimates 700 million; FedEx, 360 million. The combined total approaches two billion packages – 10 percent more than last year.

Santa Claus is planning to use new high-tech delivery methods so that he will have more time to play chess during the holiday season. The idea is to

use specially equipped drones with arms to carry and drop off gift packages at designated locations identified by GPS coordinates.

Home deliveries are complicated. Not everyone lives in a detached single family home with a chimney. Santa will have to solve the problem of delivering to high-rise apartment buildings and condos in heavily populated areas. He will need exceptional creativity and, most of all, great imagination to make the system workable.

Further experiments are in progress, such as drone deliveries to secure stations where recipients can pick up packages, as well as store deliveries direct to the trunks of parked cars.

In February, CNN reported that the U.S. Patent and Trademark Office granted Amazon a patent for a method to guide packages released from drones safely to the ground using parachutes, suggesting that Amazon is considering keeping its drones high above customers' homes, which could be practical and safe.

The patent document indicates that landing a drone takes more time and energy than releasing a package from the sky. The drone would monitor the package as it descends to assure that it lands safely.

A drone delivery system in the U.S. would require authorization by the Federal Aviation Administration (FAA). In

designing regulations, the FAA must grapple with problems of air traffic control to avoid congestion and mid-air collisions and safety of civilians and their properties on the ground.

Developing rules for air delivery by drones may not be that great a challenge for an agency that has developed rules for flying reindeer. Anything is possible.

Aside from drones, in the transportation field, various companies are experimenting with driverless automobiles, automated trains and unmanned cargo vessels. These developments, however, will take time and will provide no help to Santa this year.

Meanwhile, despite the holiday season, chess games continue at Leisure World, as illustrated by the diagram on this page.

Black is in danger of checkmate by the White Rooks at a6 and b4, but it is Black's turn

to move. What is Black's best move?

The answer follows the usual reminder that the Chess Club meets on Monday, Wednesday and Friday from 1-4 p.m. in Clubhouse II. For further information, call president Bernie Ascher at (301-598-8577).

ANSWER: Black moves the Bishop to g4, checking the King. White's only move is to e7. Black follows by moving the Rook from c5 to e5. Checkmate! So do not wait for delivery by drone. Do not wait for new FAA rules. Do not wait for Santa. Play chess now!
